EYECON TECHNOLOGIES, INC. END USER LICENSE AGREEMENT

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE DOWNLOADING, INSTALLING OR USING THE SOFTWARE OR ANY ACCOMPANYING DOCUMENTATION (COLLECTIVELY, THE “SOFTWARE”).

THE TERMS AND CONDITIONS OF THIS SOFTWARE LICENSE AGREEMENT (“AGREEMENT”) GOVERN USE OF THE SOFTWARE UNLESS YOU AND EYECON TECHNOLOGIES, INC. (“EYECON TECHNOLOGIES”) HAVE EXECUTED A SEPARATE AGREEMENT.

Eyecon Technologies is willing to license the Software to you only upon the condition that you accept all the terms contained in this Agreement. By clicking on the “I Accept” button below or by downloading, installing or using the Software, you have indicated that you are over 13 years old and that you understand this Agreement and accept all of its terms. If you do not accept all the terms of this Agreement, then Eyecon Technologies is unwilling to license the Software to you. Eyecon Technologies is solely responsible for the Software and the services that Eyecon Technologies offers (“Eyecon Services”).

1. Grant of License. Subject to your compliance with the terms and conditions of this Agreement, Eyecon Technologies grants you a non-exclusive and non-transferable license for a user to install and use an executable form of the Software on a device or devices owned, leased or otherwise controlled by you (individually your “Device” or collectively, your “Network”) for the purposes of accessing the Eyecon Services.

You acknowledge that Eyecon Technologies may choose to issue upgraded versions of the Software and may elect to do so automatically and electronically. You hereby agree and consent to such automatic upgrades and acknowledge that the terms and conditions of this Agreement will apply to any and all such upgrades.

2. Restrictions. Except as expressly specified in this Agreement, you may not: (a) copy or modify the Software; (b) transfer, sublicense, lease, lend, rent or otherwise distribute the Software to any third party outside your Network; or (c) make the functionality of the Software available to users outside your Network, beyond the scope of the license granted herein, through any means, including, without limitation, by uploading the Software to a network or file-sharing service or through any hosting, application services provider, service bureau or any other type of services; or (d) use the Software in any way inconsistent with the usage rules set forth in this Agreement. You acknowledge and agree that portions of the Software, including, without limitation, the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of Eyecon Technologies and its licensors. Accordingly, you agree not to

disassemble, decompile or otherwise reverse engineer the Software, in whole or in part, or permit or authorize a third-party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition.

You hereby represent and warranty that (i) you are not located in a country that is subject to a U.S. Government embargo, or that has been designated by the U.S. Government as a “terrorist supporting” country; and (ii) that you are not listed on any U.S. Government list of prohibited or restricted parties.

3. Ownership. The Software is licensed, not sold. You own the media on which the Software is recorded, but Eyecon Technologies retains ownership of the Software, including all intellectual property rights therein. The Software is protected by United States copyright law and international treaties. You will not delete or in any manner alter the copyright, trademark, and other proprietary rights notices or markings appearing on the Software as delivered to you. In the event of a third-party claim alleging that the Software infringes a third-party’s intellectual property rights, Eyecon Technologies will be solely responsible for the investigation, defense, settlement and discharge of any such intellectual property infringement claim.

4. Content. You acknowledge and agree that certain content made available through the Software and the Services (the “Eyecon Content”) is licensed to you by Eyecon Technologies solely for your individual, non-commercial, personal use and that you will not copy, modify or prepare derivative works based upon, redistribute, sell, transfer, publicly display, publicly perform, transmit, or otherwise use the Eyecon Content except as provided through the Software and the Eyecon Services.

5. Term. This Agreement remains effective until terminated. You may terminate it at any time by destroying all copies of the Software in your possession or control. This Agreement will automatically terminate without notice if you breach any term of this Agreement. Upon termination, you must promptly destroy all copies of the Software in your possession or control.

6. No Warranty. The Software is provided “AS IS”, without warranty of any kind. You hereby acknowledge that with respect to the Software, Eyecon Technologies has no obligation to provide maintenance or support services of any kind for the Software.

7. DISCLAIMER. EYECON TECHNOLOGIES EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT, AND ANY WARRANTIES AND CONDITIONS ARISING OUT OF COURSE OF DEALING OR USAGE OF TRADE. NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED FROM EYECON TECHNOLOGIES OR ELSEWHERE WILL CREATE ANY WARRANTY OR CONDITION NOT EXPRESSLY STATED IN THIS AGREEMENT.

8. Limitation of Liability. EYECON TECHNOLOGIES’ TOTAL LIABILITY TO YOU FROM ALL CAUSES OF ACTION AND UNDER ALL THEORIES OF LIABILITY WILL BE LIMITED TO AND WILL NOT EXCEED TWENTY (\$20) U.S. DOLLARS. IN NO EVENT WILL EYECON TECHNOLOGIES BE LIABLE TO

YOU FOR ANY SPECIAL, INCIDENTAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES (INCLUDING LOSS OF USE, DATA, BUSINESS, PROFITS OR DAMAGE TO YOUR DEVICE(S) AND/OR OTHER DEVICE APPLICATIONS) OR FOR THE COST OF PROCURING SUBSTITUTE PRODUCTS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE USE OR PERFORMANCE OF THE SOFTWARE, WHETHER SUCH LIABILITY ARISES FROM ANY CLAIM BASED UPON CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, AND WHETHER OR NOT EYECON TECHNOLOGIES HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE. THE FOREGOING LIMITATIONS WILL SURVIVE AND APPLY EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS AGREEMENT IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

Some jurisdictions do not allow the limitation or exclusion of liability for incidental or consequential damages, so the above limitation or exclusion may not apply to you.

9. Government Users. The Software and Documentation are “commercial computer software” and “commercial computer software documentation”, respectively, as such terms are used in FAR 12.212. Any use, duplication or disclosure of the Software or any documentation by or on behalf of the U.S. Government is subject to restrictions as set forth in this Agreement. 10. Export Law. You agree to comply fully with all U.S. export laws and regulations to ensure that neither the Software nor any technical data related thereto nor any direct product thereof are exported or re-exported directly or indirectly in violation of, or used for any purposes prohibited by, such laws and regulations.

11. General. This Agreement will be governed by and construed in accordance with the laws of the State of California, without regard to or application of conflicts of law rules or principles. The United Nations Convention on Contracts for the International Sale of Goods will not apply. You may not assign or transfer this Agreement or any rights granted hereunder, by operation of law or otherwise, without Eyecon Technologies’ prior written consent, and any attempt by you to do so, without such consent, will be void and of no effect. Except as expressly set forth in this Agreement, the exercise by either party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise. All notices or approvals required or permitted under this Agreement will be in writing and delivered by confirmed facsimile transmission, by overnight delivery service, or by certified mail, and in each instance will be deemed given upon receipt. All notices or approvals will be sent to the addresses set forth in the applicable ordering document or invoice or to such other address as may be specified by either party to the other in accordance with this section. The failure by either party to enforce any provision of this Agreement will not constitute a waiver of future enforcement of that or any other provision. Any waiver, modification or amendment of any provision of this Agreement will be effective only if in writing and signed by authorized representatives of both parties. If any provision of this Agreement is held to be unenforceable or invalid, that provision will be enforced to the maximum extent possible and the other provisions will remain in full force and effect. This Agreement is the complete and exclusive understanding and agreement between the parties regarding its subject matter, and supersedes all proposals, understandings or communications between the parties, oral or written, regarding its subject matter, unless you and

Eyecon Technologies have executed a separate agreement. Any terms or conditions contained in your purchase order or other ordering document that are inconsistent with or in addition to the terms and conditions of this Agreement are hereby rejected by Eyecon Technologies and will be deemed null and of no effect.
